Minimum of 15% revenue increase vs. prior year</p> <p>Chinese-American or Chinese entrepreneur whose enterprise has its headquarters in New Jersey, New York or Pennsylvania Minimum of 15% revenue increase vs. prior year Minimum revenue of \$ 1 million</p> <p>Chinese-American or Chinese woman owner or executive with company headquarters or branches in New Jersey, New York or Pennsylvania Minimum 15% revenue increase vs. prior year</p> <p>Chinese-American or Chinese individual or corporate executive who has contributed significantly to the community in New Jersey, New York or Pennsylvania</p> <p>Corporate executive in Fortune 1000 corporations (or equivalent) who has made significant contributions in increasing the participation of minority contractors in numbers and volume of contracts Awardee does not have to be Chinese-American or Chinese</p>
HOW NOMINATED?	Members and friends of NJCACC, Chinese media in New Jersey and Chinese service organizations in New Jersey, New York or Pennsylvania	
ELIGIBILITY	As detailed in above criteria; candidate could be nominated for more than one category, but a separate form must be completed for each nomination NJCACC members could be nominated; but if nominated executive/corporation is a sponsor member, the relevant board member must recuse himself/herself from the selection process of the relevant award category	
PROCESS	Up to 2 awardees will be selected for each award category by NJCACC's Board of Directors The awardees may be invited to a meeting with the NJCACC Board prior to the Gala, date/time/venue TBD The awardees will be invited to the NJCACC 5th Anniversary Gala on September, 25th for presentation
